As per the norms, based on the Family Income, the eligible students may avail below concession:

- The most economically backward students (whose family income is less than Rs.1 lakh per annum) shall get full remission of tuition fee.
 - The other economically backward students (whose family income is between Rs.1 lakh to Rs. 5 lakh per annum) shall get remission of 2/3rd of tuition fee.
- For availing above fee concession, please submit valid family income certificate issued by the authorized officials in Revenue Deptt./DC/SDM/Tehsildar, etc. (issued on or after 1st April, 2020) alongwith the notarized Affidavit (<https://www.iitmandi.ac.in/hn/academics/files/scholarships/affidavit.pdf>).**
 - The family income certificate and affidavit should be submitted on the OAS portal while making remaining payment and/or updating the fee details.**
 - If income certificate and affidavit are not submitted during the above mentioned duration, no fee concession will be permitted and the student shall pay full fee.**

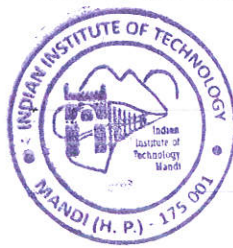
