WHEREAS SECOND PARTY is a statutory body constituted under The Institutes of Technology (Amendment Act), 2011

WHEREAS the Parties shall collaborate as per the terms and conditions mentioned hereunder.

NOW THIS MOU WITNESSESTH AS UNDER:

Article One

Purpose, Scope & Areas of Cooperation

Article Two

Nature of the MoU

This MOU does not constitute and is not intended to establish a legally binding agreement between the Parties. It solely reflects the intentions of the Parties, expressed in good faith but without creation of any legal obligation or the incurrence of any liability on the part of the Parties. The Parties agree that definitive agreements shall follow the execution of this MoU.

Article Three

Confidentiality & Exchange of Information

- 1. The Parties shall protect and maintain the confidentiality of this MoU and any relevant materials, documents and information referenced herein.
- 2. Exchange of information and knowledge related to the purpose, scope and areas of cooperation under this MoU shall be made in a timely manner in order to ensure efficient and effective outcomes.

Article Four

Amendment and Dispute Resolution

This MoU may be amended at any time by the mutual written consent of the Parties. Any dispute or difference arising out of or in connection with the interpretation of this MOU shall be amicably resolved between the Parties. Detailed clauses pertaining to dispute resolution shall be provided under the definitive agreement.

Article Five

Use of name/logos

The Parties may use the name, logo and/or official emblem etc. of the other Party pursuant to obtaining prior written approval by the other Party and such approval shall not be unreasonably withheld by the Parties.

Article Six

Validity of this MoU
